Dear Ms. Krarup:

It was a pleasure to speak with you earlier this week. You inquired about lobbyist ethics training.

As background, you advised that you lobby the City of Miami as well as Miami-Dade County. Records show that you completed the Ethics Refresher Course for Lobbyists at the Miami-Dade Commission on Ethics on July 15, 2016.

With respect to lobbying the City of Miami, the City's lobbyist ordinance requires lobbyists to complete ethics training on a **yearly basis**. City of Miami Code §2-654(a). Thus, given that you completed you last lobbyist's ethics training on July 15, 2016 your ethics training requirement for the City is valid until July 15, 2017.

With respect to Miami-Dade County, the County Ethics Code requires completion of a refresher course every **two-years**. Miami-Dade Code §2-11.1(s)(2)(d). Therefore, your ethics training requirement for the County is valid for a period of two years until July 15, 2018.

A copy of your ethics training certificate should be provided to the City as well as the County.
