Mr. Millares:

You have inquired in your capacity as legal counsel for the Miami-Dade County Value Adjustment Board (VAB) regarding a number of ethics-related issues concerning your actions as an attorney regarding issues before the board. In researching this matter, I located the attached RQO 14-02, issued by the Ethics Commission to an individual then serving as Counsel to the VAB. The Commission concluded in that opinion that the County Ethics Code does not extend

to the VAB or to the VAB Counsel since those positions are created by Florida Statutes and are governed by State law. I know this creates some confusion, inasmuch as employees at the County Appraiser's office are considered County employees who are subject to the County Ethics Code. While we may be able to give you informal advice concerning the State Ethics Code in Section 112, Florida Statutes, we are unable to provide you with the binding opinion that you really should have under these circumstances.

I strongly suggest that you seek an opinion from the Florida Commission on Ethics, which has the authority to both interpret and enforce the State of Florida Code of Ethics.
