Sylvia,

Let me do my best to answer your questions.

1) Individuals doing business with the County may be appointed to any position on the Coordinating Council so long as the contract between the Council member and the County is not subject to the regulation, oversight, management, policy-setting or quasi-judicial authority of the Coordinating Council.

2) Members of the Coordinating Council who seeking to business with the County are subject to the restrictions that are identified above. Additionally, a Council member ought to request an opinion from this office before entering into the contract with the County.

3) Members of the Coordinating Council who participate on third party missions are exploiting their official position on the Council if they exclusively promote their own businesses while on a mission.

4) Communications between Council members that involve promoting their own businesses are permissible provided these communications do not violate the Sunshine Law. A Sunshine Law violation is triggered if two board members are discussing matters that have been placed on the agenda or foreseeably might be presented to the board. Other discussion would not violate the law.

5) The County Code does not permit individuals to serve on more than one County board at a time.

6) The questions about project alteration is not something I can answer. It involves a question of delegation of authority to a committee and is more of an administrative/managerial question, not one for the Ethics Commission.

7) Members should not be using the County e-mail system to promote their own businesses. If members have other email addresses, then I see nothing wrong with exchanging this type of information as long as they are not communicating about Council business (see response #4).

8) Under no circumstances may a Council members use his/her influence to promote or seek an advantage for the individual's business.
