Dear Mr. Burgess:

I received your request for an advisory opinion regarding your father's ability to contract with the Parks Department to provide electrical services. Since you need a response prior to the next scheduled Ethics Commission meeting, I am rendering my opinion based on the facts contained in your letter.

In your letter, you advised me that the Parks Department has issued an Invitation to Bid on the Blackpoint Marina-Electrical Upgrades. You have participated in developing the specifications for the solicitation and will be involved in the selection process. Your father is President of Abacon Electric. Abacon Electric would like to bid on the project.

The Conflict of Interest and Code of Ethics ordinance prohibits your father from bidding on a contract where his son works for the department that has oversight responsibility for the project. Section 2-11.1 (d) provides that no employee "shall enter into any contract or transact any business through a firm, corporation, partnership or business entity in which he or a member of his immediate family has a controlling financial interest, direct or indirect, with Miami-Dade County or any person or agency acting for Miami-Dade County and any such contract, agreement or business engagement entered into in violation of this subsection shall render the transaction voidable." Immediate family is defined in the Conflict of Interest ordinance as spouse, parents and children. A controlling financial interest is 10% or more of the interest in the business entity.

Although the Conflict of Interest ordinance does provide an exception in some cases, it would not apply to your father's company because it prohibits contracting if the employee's job responsibilities and job description will require him or her to be involved with the contract in any way, including but not limited to its enforcement, oversight, administration, amendment, extension, termination or forebearance. Further, the exception does not apply if the employee works in the county department which will enforce, oversee or administer the subject contract.

Since you work for the department that has oversight responsibilities and you have participated in the solicitation process, the Conflict of Interest ordinance prohibits your father's company from contracting with the department to provide services.
