Mr. Forbes,

Based upon the information you have provided me, I find that no conflict of interest exists when developers who have retained your services appear before Community Council 15, the Council on which your wife sits. This conclusion is based upon the fact that your wife does not stand to profit from or be enhanced by any action the Council takes regarding the developers who have matters pending before the Council and have a contractual relationship with you. I assume that a developer's decision to utilize your services is not tied to a favorable ruling/decision from Community Council 15. If this were the case, then I would reach a different conclusion.

As an aside, although it is not conflict of interest under the County Code to address Community Council 15 as a spokesperson of the Community Advisory Committee, you and wife need to understand that when her council sits in its quasi-judicial capacity, anything that might create a sense of bias or unfairness should be avoided. Therefore, the question she has to answer is whether she can be objective about items that come before the Council when you, her spouse, is appearing either to support or oppose them.

Mr. Forbes,

Thank you for your inquiry and I discussed it over with our staff attorney. She and I agree that no conflict of interest exists if you appear as a representative of the Naranja CAA/DHS Community Advisory Committee before the Community Council on which your wife sits. However, if the Community Council is exercising its quasi-judicial authority with respect to a zoning question and you speak, there could be a claim that your wife is biased because she could be unfairly swayed by your testimony. This isn't a violation of the County Code of Ethics Ordinance, but it could be grounds for an appeal of an unfavorable ruling by the Community Council. Moreover, I assume that your appearance on behalf of the agency does not translate into a financial benefit to you or your wife. If for some reason you or your wife could benefit because of your presentation to the Community Council, then it would be improper for you to speak.
