Hi Robert- I hope that your New Year is going well so far.

I would appreciate your informal staff advice on the following matter under sec. 2-11.1 of the County Code. Would a municipal police officer of a patrol rank, who is assigned to traffic duties, be barred from working an outside employment

which consists of driving a tow truck , where the towing company that he wants to work for is a company that has an existing publicly bid contract with his own municipality for police department towing requirements. Although one approach may be to find that only the disclosure requirement of sec. 2-11.1 (f) is applicable, it seems to me that the better view likely is that this outside employment is barred by sec. 2-11.1 (c) (1) and (J). As to (J), as a traffic officer, he may have to call for and monitor other tow truck drivers from the Company as they remove vehicles . As to (c) (1), he would be transacting business with the Company as a part time employee or independent contractor of the Company, under circumstances in which that Company may be viewed as being an agency acted on behalf of the municipality. Under the public records law , companies towing for police departments have been treated as "acting on their behalf". See Fox v. News- Press Publishing Company, Inc., 545 So.2d 941 (Fla. 2 d DCA 1989) ( towing company contracted for vehicle removal from streets is performing governmental function under Chapter 119, F. S. ). Please advise me of your thoughts on this. Thanks very much for your assistance, as usual.
