Mr. Arias,

Thank you for your inquiry. I consulted with the chairman of the Ethics Commission and he and I agree that a conflict of interest would not created by the facts you have described below. As presented, you state that your spouse is a principal of a company which will be bidding on a county project and you are the Director of Public Affairs for County Commissioner Carlos Gimenez. I will assume for purposes of this opinion that your spouse has some controlling financial interest, directly or indirectly, of this company. Moreover, the county's Conflict of Interest and Code of Ethics Ordinance prohibits County officials and employees and their immediate families from transacting business with the County; however, there are several exceptions.

In prior ethics opinions, the Ethics Commission has determined that aides to County Commissioners are defined as b(6) employees – See 2-11.1(b)(6). Such employees would be transacting business with the County if they, or their immediate families, transacted business with their departments or if the employees participated in determining contract requirements, participated in the award of the contract or was involved in the enforcement, oversight, administration of the contract. In your case, you will not be participating in the award of the contract, you will not make recommendations to the Commissioner regarding this project, and you will not have any involvement with its enforcement, oversight or administration.

Therefore, as stated above, your position with Commissioner Gimenez would not preclude your spouse's company from seeking county work.
