I spoke with Jack Hartog today and I believe I have sufficient information to answer give you an opinion. As a former VP for Governmental Relations, Ms. Jules Kariher is bound by a rule, which prohibits her from lobbying PHT/JMH officials or employees for a period of two year after leaving her employment. Ms. Kariher is permitted to partner with a firm that wishes to respond to a Public Health Trust RFP as long as she is not involved in the lobbying effort to secure the contract. Therefore, she would not be allowed to meet with those who are part of the selection process. If the Proposer Akerman Senterfitt is awarded the contract, the Two Year Rule would not restrict Ms. Kariher's ability to provide the lobbying services for the Public Health Trust contemplated by the RFP.
