One question came up during the TM South Ethics training came up that I wanted to get some clarification on. I think I know the answer, but it's better to be safe than sorry.

The class wanted to know if the 2-year rule applied to employees that retired from the county vs. resigning. For example, if Joe Smith worked for the county and just retired after going into the DROP, can he go to work for a private company (part-time or full-time), which happens to have a contract with Miami-Dade or does he have to wait the 2 years?

I told them that I believe that the 2-year rule still applies, but I'd verify and get back to them.
