In order for a voting conflict to exist under the County Conflict of Interest and Code of Ethics Ordinance, one of two conditions must be met: either you must have a special relationship with the applicant or party, as defined in the Code, or you must benefit from the decision in a manner distinct from the manner in which it would affect the public generally. In this particular case you have no special association or relationship with the applicant. The applicant simply sits on a private board along with your boss and the authority of the BASF board is completely unrelated to your private employment. Furthermore, you will not profit from or be enhanced by any action or decision of the County Commissioner with respect to this application. Accordingly, no voting conflict exists that would prohibit you from participating in the discussion or voting on this
