Rena Saiter asked me to respond to your financial disclosure question. My staff general counsel and I conclude that due to the fact the Corrections Department is not specifically mentioned in the Financial Disclosure section, as opposed to Police and Fire, those in the Corrections Department with the rank of captain, major and chief do not automatically have to file. For these employees the determination will be based on their specific job responsibilities. Therefore, we can advise you whether an employee needs to file only after we receive their job descriptions.

Attached below is a question from Corrections. Could you please reply? Based on the County Code Section 2-11.1 – Page 9 is a list of County personnel that we used for the chart. We only listed what the law specified.

Also, regarding Form 1, Statement of Financial Interest for all other County employees, on your website under Financial Disclosure, indicates elected officials may file either 1) copy of the person's or firm's current federal income tax return or 2) current certified financial statement on the form approved by the State of Florida – which is Form 1 or 3) an itemized source of income statement.

Also, under State Law 112.3145 (3)c (2)(b) indicates each state or local officer and each specified state employee shall file a statement of financial interests (Form 1) no later than July 1 of each year.

Per our conversation during the Financial Disclosure Workshop, I am concerned about the Job Title/Classification listed on slides 4, 7, 9, and 10 as follows:

* Chief of Police and Fire Chief are included, but Corrections was excluded.

* Employees of the Miami-Dade Police with the rank of Captain, Major and Chief are included. Same classifications (except Major) at MDCR were excluded.

MDPD and MDCR are covered under the same bargaining unit contract. Please advise.
