There is an application process, which involves seeking initial approval through the Public Works Department and plat review by sixteen other departments, including the Department of Planning and Zoning.

Before I can answer the question, I need to know whether Mr. Holness holds these properties through a corporation or some other business arrangement. The applicable standard is that County employees are not permitted to appear in front of County boards or meet with County employees on behalf of third parties unless the matters under consideration are routine in nature.
