Dear Mr. Ford:

Thank for your letter regarding the composition of the Redland Area Municipal Advisory Committee. The legal staff has determined that a husband and a wife can be members of a committee without triggering a sunshine violation.

You are correct when you indicate that all communications between two or more members of an appointed committee must be under the sunshine law, however, the fact that they are husband and wife, is no different than if they are good friends and spending a lot of time together. In most cases, compliance with the sunshine law is an issue of personal responsibility since it is incredibly difficult to police.
