
As promised, I am providing you with a written response to the fax you sent me on October 3, 2000. Your inquiry is based on an invitation you received by Luz Picture Productions to travel to Madrid, Spain to attend events that are part of Luz' announcement that it will be opening up offices in Miami. Luz wishes to pay your airfare, lodging and incidental expenses from October 16th to October 19th, 2000. Moreover, you plan on extending your time in Spain to promote Miami-Dade County for business expansion or production, all part of your office's long-term objectives to reach out to European markets. It is my understanding that the additional time you stay in Spain will not be paid for by Luz Picture Productions; that expense will be covered by the Beacon Council, which supplies your office with a small marketing budaet.

As we discussed over the telephone, I indicated that it would not be a violation of the County's Code of Ethics and Conflict of Interest Ordinance for you to accept Luz Picture Production's invitation to pay airfare, hotel accommodations and incidentals. The purpose of this trip is for you and other officials to be present when the company announces its new offices in Miami-Dade County. This is considerably different than the company paying your way to seek to a commitment from you to do business in Miami-Dade. From what I can tell, you were not involved in negotiating the deal that brought Luz to Miami-Dade County or part of the decision-making process that resulted in the company opening up offices in Miami-Dade. If you were to play such a role in the future, it would be improper for you to accept the invitation at the company's expense. Secondly, you understand that Luz cannot pay for the portion of the trip that involves you seeking out other business opportunities for the County. Finally, you must calculate the value of the gift Luz is giving you and disclose it to the Department of Elections no later than December 31, 2000. The Elections Department has the gift form that you need to complete. If you have any questions about filling out the form, you can contact me.

Please realize that I do not have the formal legal authority to issue ethics opinions. The above represents an informal opinion; only the Ethics Commission has the authority to render official conflict of interest opinions. Due to the fact I was unable to get this on the agenda of the October meeting because you had such a short turnaround time, I agreed to give you my assessment of your question.

It was a pleasure speaking to you. Per our conversation, I have been extended an invitation by Luz Picture Productions to travel to Madrid, Spain to attend their movie premiere, gala and press conference. This invitation entails Luz Picture Productions paying for my airfare, hotel accommodations and food and beverages from October 16th through October 19th, 2000.

Luz Picture Productions is a film and television production company in Spain who will be opening their U.S. offices here in Miami in November. Luz Picture Productions has invited a group of approximately twenty notable members from our community, of which I have the pleasure to have been included, in an effort to have a Miami-Dade County presence at these events where they will announce the opening of their offices in Miami.
