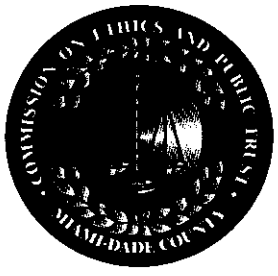

Dear Ms. Morales,

I am in receipt of a fax which was received in my office on June 12, 2002 wherein you are seeking to be released from all County ordinances, rules and regulations based upon the fact you tendered your resignation to Harvey Ruvlin, Clerk of the Courts (letter dated June 10, 2002). My authority is limited to releasing you from all sections of the Miami-Dade County Conflict of Interest and Code of Ethics Ordinance (2-11.1), with the exception of subsection (q). Subsection (q) mandates that former County employees are barred from lobbying the County for two years after County employment ceases. With respect to other issues you raise in your letter, I suggest you contact the County Attorney's Office or the Employee Relations Department directly.
