There is no conflict under the ethics ordinance for a person to sit on a county board and a school board committee. The more relevant question is whether a conflict of interest is created based on your job responsibilities with the county and the purview of the School Site Selection and Construction Committee. If the Committee's work involves making recommendations or taking action on matters that are related to activities of the Planning and Zoning Department, then I would advise against you serving on the committee. Also, in the event you were privy to confidential information, either as a county employee or as a member of the School Committee, you would be barred from divulging that information to third parties. Absent these two conditions, I do not believe there is a conflict of interest.

- 1) I am a member of Miami Dade County Asian American Advisory Board. The members are appointed by the County Commissioners and are charged to promoting and advising the County Commission on issues affecting the asian community. The Board does not or is not expected to interact with the Planning and Zoning in a regulatory setting. Can I continue to serve on the Board?
- 2) I also serve on Miami Dade County School Board's School Site Selection and Construction Committee as an "Architect" member and appointed by the School Board Chairperson. As a result of the Interlocal Agreement, the Committee size has been expanded to include representatives from the County and the various municipalities. Helen Brown is our representative on the Committee. Do you see a conflict of my continuing to serve on this Committee?

Note: I have asked the same question to the School Board folks, there may not be a conflict but they may have a problem with two County employees in the Committee. We will see what they say.
