Sorry I haven't responded sooner, but I wanted to run this by our general counsel before answering your questions. Based upon the facts you have given me, I understand that you sit on the board of directors of the West Kendall Optimist, a community-based organization. You serve the organization as a volunteer, but you have occasionally appeared before boards to promote the Club's positions. Furthermore, you have filed building permits on behalf of the Club. Finally, you are a full-time County employee.

Section 2-11.1(m) prohibits County employees from appearing before County boards and agencies on behalf of third parties. Therefore, if you appear before County boards to promote the positions of the West Kendall Optimist Club, then you would be in violation of the ordinance. If you appear before non-County boards, then this Code section does not apply. As far as filing permits is concerned, I would prefer to present this question to the Ethics Commission at our next meeting. At our June meeting, the Ethics Commission found that filing building permits for private clients represents an "appearance" under the Code. However, this arose in the context of County employees who are hired as paid consultants by individuals or firms. In your case, you do not profit from the filing of these permits. Hence, the Ethics Commission might arrive at a different result.

Please let me know how you wish to proceed with respect to the question of filing permits.
