Hi Maude:

I reviewed your question with Mike. Under the Code of Ethics, members of semiautonomous authorities, boards and agencies; quasi-judicial personnel and advisory personnel, whose sole responsibility is to make recommendations to the City Council, are required to comply with the financial disclosure requirements outlined in Section 2-11.1 (i).

You indicate that the members of the Housing & Commercial Loan Committee, a city created board, approve and disapprove specific housing and commercial loan and/or grants provided by the City through the Community Development Block Grant (CDBG), Home Investment Partnership (HOME) and State Housing Initiatives Partnership (SHIP) Program. It appears that these members would fall under the definition of autonomous personnel, under Section 2-11.1 (b)(2); and accordingly, would be required to file one of the three forms by July 1st: income tax return; certified financial statement; or an itemized source of income statement.

Please advise those Committee members of this requirement. Should you have any additional questions in the meantime, do not hesitate to contact me.
