This is to inform you that I received your fax on Friday, October 12<sup>th</sup> and I wanted to provide you with a prompt response. Along with your fax, you sent me a letter from the Florida Philharmonic inviting Commissioners Sosa to attend an October 27<sup>th</sup> concert at no charge to her. Additionally, the Philharmonic is willing to give Commissioner Sosa up to twenty (20) additional tickets free of charge. You want to know whether Commissioner can accept the one ticket for herself and distribute the other tickets as she pleases.

I reviewed this matter with our staff counsel and we agree that Commissioner Sosa would not be in violation of the gift rule if she chooses to attend this performance and accept this complimentary ticket. Commissioner Sosa, however, is required to report the free ticket as a gift on a gift disclosure form, filed with the Clerk of the Board, if the value of this ticket exceeds \$25. Similarly, if she chooses to distribute any of the other tickets to her staff and/or County employees, they, too, would have an obligation to disclose the tickets as gifts.

If you have any additional questions, please contact me at your convenience. If you would like to Ethics Commission to hear this matter, I can make arrangements for the item to be on our next agenda.
