A story appeared in The Miami Herald regarding a television show "trailer" produced for the purpose of marketing it to the networks for a television series. The TV series would chronicle the challenges faced by the City of Miami Police Department's elite task forces. Pursuant to the article, Jorge Moreno, owner of Beach Pictures, LLC, and his friend, Tommy Regalado, the Mayor's son, discussed the idea of the television series about one year ago. Tommy Regalado is reported to have introduced his friend to the top brass of the City of Miami Police Department, most notably Chief Miguel Exposito, in order to propose the idea. The trailer was produced by Beach Pictures LLC (Beach) with the full cooperation of the City of Miami Police Department, and was ready to be sold to the networks by October 2010. On January 25, 2011 the COE opened an inquiry concerning issues related to a possible violation of the Conflict of Interest and Code of Ethics Ordinance Section 2-11.1(c) Prohibition on transacting business within the County (or City). There was concern that the mayor's son may have been improperly contracting with the City.

## **Investigation:**

The COE made a public record request from the City of Miami asking for copies of all e-mails to and from Chief Miguel Exposito, Tommy Regalado and Jorge Moreno in reference to the production of the trailer for "*Miami's Finest SOS*". The COE also requested a copy of the Letter of Interest signed by Chief Exposito, Jorge Moreno and former City Manager Carlos Migoya.

The following is a chronology of events as reflected by e-mails provided by the City of Miami:

## 2/28/11 – Jorge Moreno, Beach Pictures, Inc.

On 2/28/11 Moreno rendered a verbal statement at the offices of the COE. Moreno's statement focused on the events leading up to the production, viewing and initial marketing of the trailer.

Moreno explained that Beach was formed about three years ago when he partnered with Adrian Baschuk and Nathan Lieberman. Moreno advised that Beach has been doing very well and has become the "go to" company in Miami for film production.

Moreno explained that he and Tommy Regalado have been friends for a long time, and both are in the TV business (Regalado works for TV Marti).

Moreno explained that he and Tommy Regaldo have talked about different projects for television including this project which they agreed was a great idea.

Moreno advised that he asked Tommy Regalado how he could meet the Chief. Moreno stated that Tommy Regalado arranged to have a breakfast meeting at Versailles Restaurant. The meeting took place in January or February of 2010. In attendance at the meeting were Moreno, Tommy Regalado, Chief Exposito, Alfredo Vega, and Major Jose Seiglie, Moreno said there was someone else at the, meeting but he does not remember who it was. The mayor was not there. Moreno explained that at the meeting he proposed to produce the trailer on the topic of grow houses, which was a hot topic at the time. Moreno stated that Chief Exposito thought it would be boring and suggested to base the show on the Tactical Operation Section ("TOS"), which is a unit of "super cops." Moreno informed that he was riding with the TOS police two weeks later with the full cooperation and assistance of Major Seiglie, the head of TOS. Moreno said that he signed all the necessary documentation related to liability issues. Moreno advised that he, and his partners, Adrian Baschuk and Nathan Lieberman, and cameraman/director Stian Roenning rode along with the TOS officers filming the trailer for about one month. Moreno stated that Tommy Regalado did not ride along with them and was not involved at any level in the production or marketing of the trailer. Moreno added that the only thing Tommy Regalado did was introduce him to Chief Exposito.

Moreno advised that the City has not paid any money to Beach or provided any equipment for the production of the trailer. Furthermore, the City stands to make money if any of the networks or cable outlets buy the trailer. Moreno explained that they made the trailer to show the network the gist of what the show would be like. Moreno advised that by the end of November they had showed the trailer to TLC and A&E. TLC wanted to develop a season of the show.

Moreno advised that they held a viewing party for the officers on 10/7/10 at the Catalina Hotel/Kung Fu Restaurant Lounge. Moreno advised that they made two versions of the trailer, one for the networks and one for the viewing party. Moreno stressed that everyone loved it, including the Chief. Moreno advised that Tommy Regalado did not attend the viewing party. Moreno explained that he listed Tommy Regalado's name in the credits on the viewing party cut of the trailer as a gesture of gratitude, but regrets doing it.

Moreno explained that someone leaked the trailer to Commissioner Dunn and it got to the press. Since then, the Chief has said that the trailer was manipulated. Moreno said that this is the Chief's project and now he wants to kill it because he got bad press from it. Moreno stated that he was told by Alfredo Vega to get the trailer from Commissioner Dunn or else they will not let him have a show. Moreno said getting the trailer from Commissioner Dunn was impossible to do at that point.

## **Conclusion:**

There was no evidence that Tommy Regalado contracted with the City or profited from the endeavor. No violation of the Conflict of Interest and Code of Ethics Ordinance was identified. For that reason, no further action will be taken by the COE on this matter.
