Allegation(s):

- 1) Potential violations of Florida Election Code where an Electioneering Communication Organization (ECO), run by the subject, specifically advocated for the election or defeat of a certain candidate for Miami-Dade County Property Appraiser. Unlike Political Action Committees (PACs) and Committees of Continuous Existence (CCEs), ECOs are prohibited from expressly advocating the election or defeat of a certain candidate.

Applicable Law:

F.S. 106.011(9), clearly defines that ECOs are limited to certain activities that would not otherwise require the group to register as a political party or committee.

F.S. 106.011(16)(a)(3), a political committee is permitted to make expenditures that “expressly advocate the election or defeat of a certain candidate.”

Investigation:

Interviews

None. Received an anonymous tip, and a copy of the mailer distributed by The Future Is Now, which was supposedly sent to at least two registered voters living in the city of Miami. A second copy of the mailer was also sent anonymously to Investigator Manuel W. Diaz.

Document/Audio/Video Review:

- 1) Copy of mailer sent by The Future Is Now ECO, which was supposedly received on or about Election Day, Nov. 5, 2014.
- 2) Copy of various state of Florida, Division of Elections, records indicating that Francis X. Suarez is the chairman of The Future Is Now ECO and that Jose Riesco is the registered agent and treasurer.
- 3) Annotated versions of the relevant sections of FS 106.011 mentioned above in “Applicable Law”
- 4) Signed confidential complaint form submitted to the Florida Elections Commission

Conclusion(s):

After consulting with the Advocate and the Deputy General Counsel, we are referring this case to the state Elections Commission via confidential complaint (See Document #4 above).

Suarez, who is an elected Miami commissioner, is also chairman of The Future Is Now. The ECO distributed a mailer attempting to affect the outcome of the recently completed 2014 campaign for Miami-Dade Property Appraiser between Pedro J. Garcia and Eddy Gonzalez.


Under F.S. 106.011 (9), ECOs are limited to certain activities that would not otherwise require the group to register as a political party or committee. Under F.S. 106.011 (16)(a)(3), a political [action] committee is permitted to make expenditures that “expressly advocate the election or defeat of a certain candidate.”

One side of the mailer distributed by Suarez’s ECO expressly advocates for Gonzalez’s election. It quotes Suarez, in Spanish and English, advocating for Gonzalez. Suarez’s photograph appears adjacent to the quotes. The same side of the mailer discloses it as “Paid electioneering communication paid for by The Future Is Now.” The opposite side of the mailer attacks Gonzalez’s opponent, Garcia.

The address listed on the mailer – 95 Merrick Way, Suite 250, Coral Gables, FL 33134 – is the address of the ECO’s registered agent and treasurer, Jose A. Riesco of Riesco & Company LLC.


While this type of advocacy campaign material is legal for PACs and political parties, it is illegal under state law for ECOs such as The Future Is Now.




