#### Mr. Fernandez:

This is in response to the request of Commissioner Rebeca Sosa, Miami-Dade County Commission (DIST 6), regarding whether she may participate and vote on Item No. 181011 on the agenda for the May 1, 2018 meeting of the Board of County Commissioners. This item is a Resolution urging the Miami-Dade County Public Schools to include technical and vocational training at One-Stop Educational and Community Service Centers. One-Stop Educational and Community Service Centers were formed through a partnership between the Miami-Dade County Juvenile Services Department and the Miami-Dade County Public Schools (MDCPS) and several community partners to provide transitional services for youth reentering the community after release from confinement or juvenile justice programs. The centers offer comprehensive educational assessment, specialized educational services, and referrals appropriate MDCPS support services, as well as transition advisement and placement in a K-12, high school completion program or adult vocational-technical education programs.

The issue is raised due to Commissioner Sosa's full-time employment with MDCPS as curriculum/program facilitator for services related to the countywide South Florida Workforce one-stop delivery system at the Lindsey Hopkins Technical Education Center. It concerned me that the description of the program that will be implemented under this Resolution seemed to be related to the work that Commissioner Sosa does for MDCPS. Therefore, I requested that you look further into it to find out whether her position could be affected. You have confirmed that Lindsey-Hopkins is one of the facilities that could be included in this program.

Although we have not in the past deemed employment in a governmental agency, such as MDCPS, to create an automatic voting conflict under Section 2-11.1(d) of the County Ethics Code, the latter provision has a broad voting conflict provision that would apply if the Commissioner "would or might, directly or indirectly, profit or be enhanced by the action of the Board..." Because there appears to be a possible impact on the school facility where she is employed, and because the impact might, directly or indirectly, affect the services she provides there, there is a possibility that she could, in some way, profit or be enhanced by the vote on this issue. Therefore, unless it can be determined with certainty that there will be no impact on her position, I would recommend that she recuse herself from the vote under Section 2-11.1(d). The recusal would require that she announce publicly that she may have a conflict under Section 2-11.1(d); that she leave the chambers during the discussion and vote on the item; and that she file a copy of State Form 8B (attached) with the Clerk's office within 15 days of the vote.

WHEREAS, One-Stop Educational & Community Service Centers ("Centers") were formed through a partnership between the Miami-Dade County Juvenile Services Department, the Miami-Dade County Public Schools ("MDCPS") and several community partners to provide transitional services for youth reentering the community after release from confinement or juvenile justice programs; and

VOCATIONAL TRAINING AT ONE-STOP EDUCATIONAL

**WHEREAS**, to ensure student success in the transition back to an educational setting, the Centers offer several onsite services in one central location; and

WHEREAS, the Centers offer youth comprehensive multi-disciplinary educational assessment and recommendations; referrals to appropriate MDCPS support services; transition advisement and placement in a K-12, high school completion program or adult vocational-technical education program; educational case management; academic progress monitoring; specialized educational services that utilize family and community interventions; and support and alternative to suspension services; and

WHEREAS, youth at the Centers would benefit from inclusion of an onsite vocational-technical education program that can provide youth employment skills and required certification in a variety of in-demand jobs, including electrician, plumber, heating, ventilation and air conditioning technician, cosmetologist, welder, auto mechanic, heavy equipment operator and truck driver; and
