Ms. Carballosa:

This is in response to your inquiry regarding whether lobbyist registration documents, specifically, the Contingency Fee Affidavit, filed by a client of yours residing in London, would be acceptable where the notary attestation is in a slightly different form from that which a notary in the State of Florida would complete. You informed that the intent was for your client to sign the same affidavit that is required for the registration of all lobbyists in Miami-Dade County, which requires lobbyists to register on forms prepared by the Clerk. Section 2-11.1(s)(2)(a). However, due to the fact that the notary attesting to the signature is a London, England Notary rather than a State of Florida Notary, the format of the attestation will be different and will reflect that the notarization is taking place in the City of London and the country of England, and is being attested to by a scrivener notary under seal in that jurisdiction. It is my opinion that this would be acceptable because the form is the substantially the same as that utilized in Miami-Dade County, and the purpose and import of the attestation is also substantially the same, i.e., a sworn statement indicating that the individual signing the form is, in fact, the same individual indicated on the form.

I have discussed this with Claude Francis in the Miami-Dade Clerk's Office, who indicated that his office would abide by the opinion of this office.
