Dear Ms. Layne,

You inquired about lobbyist ethics training.

As background, you advised that you work for Kimley-Horn. Kimley-Horn has some employees that lobby Miami-Dade County and the City of Miami. You wanted to know how often the employee lobbyists have to take the ethics refresher course.

With respect to Miami-Dade County, the County Ethics Code requires completion of the ethics refresher course every **two-years**. Miami-Dade Code $\S(s)(2)(d)$.

With respect to lobbying the City of Miami, the City of Miami amended §§ 2-651- 2-658 of Article VI, *Lobbyist*, effective January 1, 2018. Section 2-654 (b) states in part, "Lobbyists who have completed the initial Ethics Course mandated by the preceding sentence and have continuously registered as a Lobbyist thereafter shall be required to complete a refresher Ethics Course every two (2) years. Each Lobbyist who has completed a refresher Ethics Course shall submit to the City Clerk a certificate of completion within sixty (60) days after registering as a Lobbyist." All lobbyists' registrations expire December 31st. *See* §2-654 (a), Miami Code.

This matter was previously discussed with City of Miami Assistant City Attorney Xavier Albán who advised that the revised Lobbyist ordinance is **prospective**. *See* INQ 18-29, INQ 18-118. Consequently, if the lobbyists took the Ethics Course in 2017 and have re-registered to lobby in 2018, they will be required to take the refresher Ethics Course this year which will satisfy their ethics course requirement for the next two years. *See* INQ 18-118.
