Dear Mr. Pacheco,

You registered to lobby Jackson Memorial Hospital sometime in June 2018. You have also registered for the August 10, 2018 Ethics training course. You inquired whether you may engage in lobbying activities prior to taking the course on August 10, 2018.

The Miami-Dade County Ethics Code at Section 2-11.1(s)(2)(d) requires those who register to lobby in Miami-Dade County to complete lobbyist ethics training offered by the Miami Dade County Commission on Ethics and Public Trust within 60 days of registering as a lobbyist. Upon registering to lobby, you are permitted to commence lobbying, and then take the four-hour course within 60 days following the registration. See INQ 15-210, INQ 13-171, INQ 13-189, and COE's Lobbying in Miami-Dade County FAQ's 2015.

However, please note that lobbyists who do not complete the lobbyist ethics training provided by the Commission on Ethics within the required 60 days, may not lobby until the training has been completed. See INQ 18-96, and INQ-17-289 (Lobbyist ethics course should be completed within 60 days of initial registration as a lobbyist, or must be completed prior to an individual engaging in lobbyist activities thereafter).
