Dear Mr. Ochoa,

You have inquired about possible conflicts of interest between your County employment and your proposed outside employment.

Background

You are a Customer Service Representative II at the Miami-Dade Water and Sewer Department (WASD). Your job responsibilities include assisting customers with issues that they may have with WASD through the WASD call center.

You are seeking to engage in outside employment as a referee for Miami Roller Hockey LLC (MRH). MRH is an adult roller hockey league. In your role as a referee, you will provide services for youth and adult constituents from various municipalities throughout the South Florida area. You will not service any contract that MRH has with Miami-Dade County.

You have represented that in your County position, you do not have the authority to approve or disapprove any agreements for services between the County and MRH; you have no involvement in the selection, oversight, or administration of the County contract with MRH; and you have no responsibilities and/or duties at WASD that involve MRH.

Legal Analysis

Sections 2-11.1(j) and (k) of the County Ethics Code prohibit County employees from engaging in outside employment which would impair the County employee's independence of judgment in the performance of his or her official duties or create a conflict between the County employee's public duties and his or her private interests. The County's Administrative Order 7-1 reiterates the general principle that County employees must conduct the public's business without even an appearance of conflicting loyalties: "Under no circumstances shall a County employee accept outside employment...where a real or apparent conflict of interest with one's official or public duties is possible.

Based on the facts presented here, we find that your proposed outside employment as a referee is not likely to create conflicting employment because: your public duties as a Customer Service Rep II and you job duties as referee are not closely related; the employment would occur outside of you County hours of employment; and your department does not contract with, oversee, or administer MRH's contract with the County because MRH does not contract with the WASD.

However, we caution that County employees cannot use County time or resources in the furtherance of their outside employment (Miami-Dade Code § 2-11.1(g)); they are prohibited from using any confidential information acquired as a result of their County employment to derive a personal benefit (Miami-Dade Code §2-11.1(h)); and they cannot represent their outside employer in any matter before the County (Miami-Dade Code § 2-11.1(m)).

Furthermore, we remind you that all County employees engaged in outside employment must obtain permission to engage in that employment on a yearly basis. Miami-Dade Code §2-11, Administrative Procedure 7-1, and Procedure 403. In addition, County employees employed by County vendors must file an Affidavit with the Miami-Dade Clerk of the Courts disclosing employment with that vendor (Miami-Dade Code §2-11.1(f)).

Finally, all **full-time** County Employees who engage in outside employment are required to file an Outside Employment Statement reporting the annual income they received from their outside employment on a yearly basis with the Miami-Dade County Elections Department by noon on July 1. (Miami-Dade Code §2-11.1(k)(2)).



Miami-Dade County <u>Administrative Order 7-1</u> and <u>Procedure 403</u> require that any County employee intending to engage in outside employment must first obtain approval from his/her Department Director using this Request for Outside Employment form. These approvals must be renewed on an annual basis. Copies of all outside employment approvals shall be maintained in the centralized personnel files of the Human Resources Department. Each County department shall also maintain appropriate records regarding outside employment requests. <u>Full-time County employees</u> engaging in outside employment must <u>also</u> file an <u>Outside Employment Statement</u> form with the Elections Department by July 1stofeach year, in accordance with §2-11.1(k)(2) of the Miami-Dade County Code.
