Ms. Prado,

You have inquired regarding whether there is anything in Chapter 119, Florida Statutes that would prohibit a municipality from getting an upfront deposit before commencing work on a public records request.

While your inquiry references a Florida state statute, this agency has jurisdiction over public records issues by virtue of Section (A)(3) of the Miami-Dade County Citizens' Bill of Rights, under which it has the authority to enforce the latter provision consistent with the requirements of Chapter 119, Florida Statutes.

The courts in this State have interpreted Chapter 119 to permit a municipality to establish a reasonable policy imposing an advance fee for the production of public records. See *Morris Publishing Group, LLC v. State,* 154 So. 3d 528, 534 (Fla. 1st DCA 2015, *review denied,* 163 So. 3d 512 (Fla. 2015) and *Accord Board of County Commissioners of Highlands County v. Colby,* 976 So. 2d 31, 37 (Fla. 2d DCA 2008).

Based the authority noted above, it is permissible to require a deposit on a public records request as long as it is reasonable under the circumstances of the request.
