Dear Ms. Thomas:

You asked about possible conflicts of interest between your County employment and your proposed outside employment as a Parent Coordinator with the Overtown Youth Center, a County Vendor.

Background

As background, you are employed at the Miami-Dade Corrections and Rehabilitation Department (MDCR) as a Corrections Technician. Your job duties include administrative work such as answering phones, date entry, processing incoming inmates, and scheduling inmate court hearing dates.

You are seeking outside employment as a Parent Coordinator with the Overtown Youth Center(OTYC). The Parent Coordinator is a paid position involving duties such as working in conjunction with the program principal to address student concerns and problems and performing site visits with the students and parents in order to address those concerns. The OTYC is a County vendor, but County personnel informs us that it does not contract with the Corrections Department which employs you. You advise that this work would occur outside of your hours of County employment.

Legal Analysis

Sections 2-11.1(j) and (k) of the County Ethics Code prohibit County employees from engaging in outside employment which would impair the County employee's independence of judgment in the performance of his or her official duties or creates a conflict between the County employee's public duties and his or her private interests. Based on the facts presented here, we have discussed this matter with your supervisor and concur with her that your proposed outside employment as a Parent Coordinator with the OTYC is not likely to create conflicting employment for the reasons listed below.

• Your public duties as a Corrections Technician with MDCR focus on administrative tasks such as processing incoming inmates and setting court dates and do not involve contacts with the OYTC. Furthermore, your work duties with OTYC as a parent coordinator addressing problem areas for students is different from the

- work you perform at MDCR. Therefore, your County duties and the duties of your outside employment are not closely related. *See* COE Outside Employment Guidelines (2017).
- Conflicts are also unlikely because while the OTYC is a County vendor, it does not contract with the MDCR and therefore this outside employment will not likely cause you to come into contact with the same or similar people or entities in both your outside employment and your public duties. *See* COE Outside Employment Guidelines (2017).
- Your outside employment would occur outside of your County hours and mostly outside of Miami-Dade County. *See* COE Outside Employment Guidelines (2017).

However, please note that the following **limitations** would apply:

- You may not use County time or resources in your outside employment. (Miami-Dade Code § 2-11.1(g), Miami-Dade Code 2-11 and AO No. 7-1.)
- You may not use any confidential information acquired because of your County employment to derive a benefit for yourself or for your private employer. (Miami-Dade Code § 2-11.1(h));
- You may not represent your private employer in any matter before the County (Miami-Dade Code § 2-11.1(m)).

Lastly, we remind you that all County employees engaged in outside employment must complete the outside employment paperwork on a *yearly basis*
