Mr. Bello:

You have submitted a request for opinion from Miami-Dade County Commission Vice-Chairwoman Audrey Edmonson (DIST3) concerning whether she would have a voting conflict of interest under Section 2-11.1(d) of the County Code of Ethics in participating and voting on a proposal submitted to the County by the Community Development Corporation (CDC) of the St. James AME Church for a transit-related County project. You have informed that Vice Chairwoman Edmonson is a member of the St. James AME Church and that she holds the position of Steward of the Steward and Finance Committee of the Church, which makes her, in effect an officer of the church. You have advised that the CDC is a separate 501(c) entity from the Church, and that the Church has no involvement in or stake in the proposal by the CDC, and that the Vice Chairwoman also has no involvement in the CDC and no personal stake or interest in the proposal apart from whatever general interest other community or church members may have in it.

I have consulted with Rev. Jimmy Williams, the pastor of St. James AME Church. He confirmed that the project, a renovation of the Earlington Heights Metrorail Station, is not located in the nearby vicinity of the church and would not have any measurable impact on the church.

The Vice Chairwoman's status as an officer of the Church would, by itself, create a voting conflict of interest only if the church itself would be affected by the project in question. It is my understanding that this is not the case. I also understand that Vice Chairwoman Edmonson has no personal or financial stake in the project that could cause her to personally profit or be enhanced by the Commission action on the proposal.

Under these circumstances, I do not find that Vice Chairwoman Edmonson would have a voting conflict of interest that would prohibit her from voting on or participating in the item when it comes before the Board of County Commissioners. The mere fact that she may be the County Commissioner for the area involved does not itself create any conflict under the ordinance without her having a personal stake or her church being affected by the project.
