Mr. Pepe:

What kind of legal representation will the chosen firm provide. Will they lobby on behalf of the city? They will be representing the City in the negotiations of a Comprehensive Agreement with an entity that responded to a solicitation pursuant to 255.065, Fla. Stat.

Please explain under what circumstances the city is holding a "non-public" meeting? Pursuant to what authority is there a public meeting where there is no right for the public to speak?

Not all of the City's actions, pursuant to its Charter, require public hearings. The public has a right to speak at the time of public comments that come at the beginning of the meeting and before all resolutions are addressed. At that time, the public can address any matter, including resolutions that are to be heard that night.

What type of information will the commissioners ask? Will they regard the terms of the proposed contract on which the firms will bid?

I don't know if any of the commissioners will have any questions. Therefore, I don't know what questions they may ask. They may ask a question about the terms of the firm's agreement, any conflict of interest, waiver of conflict of interest, etc.

Under any circumstances, there is no penalty for registering as a lobbyist- it is best to do so if there are any questions as to whether lobbying will occur. When in doubt, it is best to register. That is the advice we always provide.

The problem is that our lobbying ordinance requires registration by 3:00 p.m. the day before the meeting and it is now too late to formally register.
