You inquire whether there is a conflict of interest between your proposed outside employment and your position as the Fit 2 Lead Area Coordinator for South Miami-Dade County, at Miami-Dade County Parks, Recreation, and Open Spaces Department. Your request for outside employment was denied by your department director.

With regard to the denial or approval for outside employment, the Ethics Commission has clarified that the final decision to grant an employee permission to engage in outside employment rests with the employee's department director. Such decisions may be based on staffing needs, departmental policies, collective bargaining agreements, personnel issues, performance issues, conflicts of interest, etc. See RQO 00-10, RQO 12-07, INQ 18-24, INQ 18-212.

Although this office may assist your department director from the perspective of whether there is a legal conflict between your outside employment and your municipal duties, final determination as to whether you should engage in outside employment rests with him or her and this office will not interfere with your Department's decision. See INQ 17-48 and INQ 18-212.
