Mr. Caprara,

The acceptance by the Miami-Dade County Medical Examiner's office of the donation from VITAS Hospice of a pedestal valued in excess of \$1000 as well as palm trees and catering, all of which could exceed \$2000, for the purpose of honoring the late Dr. Bruce Hyma, the longtime director of the ME's office, at the ceremony renaming the County Cemetery as the Dr. Bruce A. Hyma Memorial Cemetery, would not, in my opinion violate any provisions of the County Code of Ethics. Gifts provided for the sole use and benefit of the County are generally exempt from the County gift ordinance in Section 2-11.1(e) of the Code. The donation is not for the benefit of any individual connected to the county, but rather for the benefit of the County. Coming from an entity such as VITAS Hospice and being intended to honor an individual such as Dr. Hyman, it does not appear that there would likely be any purpose to the gift other than the honoring of an individual deemed worthy of such commemoration.
