Re: INQ 18-95, Limitations on Doing Business with Miami-Dade County

Dear Ms. Fernandez:

You have inquired whether the County Ethics Code would prohibit your privately-owned company from contracting as a vendor with Miami-Dade County.

As background, you are seeking to become a Miami-Dade County vendor through your privately-owned company, Healthy Craze Miami Vending ("Healthy Craze"). Neither you nor your husband are County employees, and you advise that you do not have any relatives that are employed by the County. However, your husband is an elected official for the Village of Virginia Gardens. You inquire whether your husband's service as an Virginia Gardens elected official would preclude you from contracting with Miami-Dade County.

The County Ethics Code prohibits elected officials or their immediate family members from contracting with the governmental entity where the elected official serves. *See* Miami-Dade Code §§ 2-11.1 (c) and (d). In this case it would mean that you would be **prohibited from contracting with <u>Virginia Gardens</u>** either individually or through your privately-owned firm, Healthy Craze, because your husband serves as an elected official there.

However, the Ethics Code's limitation on contracting does not apply when a covered person is seeking to contract, not with their own governmental agency, but with an agency of **another** local government. Therefore, the County Ethics Code does not prohibit you or Healthy Craze from contracting with Miami-Dade County because neither you, nor any of your family members are County employees, and your husband is not a County employee or a County elected official.

Consequently, Healthy Crazy Miami Vending may enter into contracts with Miami-Dade County. Nevertheless, neither you nor your husband may use his position as a Virginia Gardens elected official to secure **special privileges or exemptions** with respect to the contract. *See* County Ethics Code §2-11.1(g).

This opinion is limited to the facts as you presented them to the Commission on Ethics regarding conflicts under Subsections (c), (d), and (g) of the Miami-Dade Conflict of Interest and Code of Ethics Ordinance only. Other conflicts, based on directives from your son's Department or under state law, may apply. Questions regarding the state ethics laws should be addressed to the State of Florida Commission on Ethics.






