Dear Mr. Gimenez:

You have inquired whether you may lobby prior to completing lobbyist training within the initial 60 days of your registering as a lobbyist.

Section 2-11.1(s)(2)(d) requires that: "Each lobbyist shall, within sixty (60) days after registering as a lobbyist, submit to the Clerk of the Board a certificate of completion of an ethics course offered by the Miami-Dade County Commission on Ethics and Public Trust." Consequently, the Ethics Commission has determined (see attached INQ 17-191) that County lobbyists have sixty days to complete the training during which time they may lobby.

However, if you do not complete the lobbyist ethics training within 60 days, you will be unable to lobby thereafter until you have completed the training. *See* INQ 17-289 (Lobbyist ethics course should be completed within 60 days of initial registration as a lobbyist, or must be completed prior to an individual engaging in lobbyist activities thereafter).
