Thank you for contacting the Miami-Dade Commission on Ethics and Public Trust and requesting our guidance regarding financial disclosure requirements.

<u>Facts</u>: You serve as the Assistant General Counsel for the Dade Police Benevolent Association (PBA). One of the PBA members served as an acting and interim Chief of Police for a municipality in Miami-Dade County from July 2017 through November 2018. You advise that your client was never informed that she was required to file financial disclosure documents in her role as acting and interim Chief or Police for the municipality.

Issue:

Whether an interim Chief of Police is required to file a financial disclosure form for the time period during which she held the acting and interim Chief of Police position for the municipality.

Discussion and opinion:

Section 2-11.1 (i) requires that certain County and Municipal personnel file financial disclosure on a yearly basis. This section also specifies that compliance with the financial disclosure provisions of Chapter 112, Florida Statutes, shall constitute compliance with the County Ethics Code. In other words, persons who are required by state law to file a state financial disclosure form (State Form 1 or 6), satisfy the local financial disclosure

requirement by filing the state form and do not also have to file the local financial disclosure form (Source of Income form).

State law and the County Ethics Code provide that a person holding the position of Chief of Police must file financial disclosure. Pursuant to Florida Statute 112.3145(a), a Chief of Police would file a State Form 1 with the Elections Department in the County where he or she resides. We assume for purposes of this inquiry that the person has not held a position during the reporting period that would require her to file a State Form 6 (certain elected officials, etc.). Information on filing State Forms 1 and 6 can be found at the Florida Commission on Ethics website at http://www.ethics.state.fl.us/. Also, attached is the Financial Disclosure Chart prepared by the COE annually which outlines state and local financial disclosure requirements.

The Miami-Dade Commission on Ethics does not interpret Chapter 112, Florida Statutes. However, after conferring with the Florida Commission on Ethics, which has jurisdiction over this matter, they advise that persons in acting or interim positions who assume the duties of that position are "local officers" for purposes of the financial disclosure law. Similarly, the Miami-Dade Commission on Ethics considers that personnel authorized to assume municipal or County functions on an interim basis which would normally be required to file financial disclosure, would file a financial disclosure for the time in which they held that covered position. *See generally* RQO 11-07 and RQO 13-01. Consequently, a person who served as an interim and acting Chief of police who assumed the duties of that position must file a financial disclosure for the period of time during which she held that position.

Persons covered by Chapter 112, must file a State Form 1 within 30 days of appointment or employment and then annually by July 1 of each year. Persons filing State Form 1 report financial interests for the previous year. Using the dates you provided, this would mean that your client would have to file financial disclosure for several years. A 2016 Form 1 should have been filed within 30 days of the July 1st, 2017 appointment, and a 2017 Form 1 should have been filed by July 1st, 2018. In addition, covered persons must file a Final Statement of Financial Interests (STATE FORM 1F) within 60 days after leaving office or employment (unless taking another position that requires filing either Form 1 or Form 6). In this instance, it would mean that this person would also file a 2018 Form 1F within 60 days of leaving the office in November 2018. These forms can be found on the Florida Commission on Ethics website. Completed forms should be filed with the Elections Department in the County where your client resides. It might also be advisable to send a copy of the forms to the Florida Commission on Ethics at: CEForm1@leg.state.fl.us.

Additional questions regarding late or non-filing of State Form 1 should be addressed to the Florida Commission on Ethics. Filing a State Form 1 or 1F also satisfies the Miami-Dade County financial disclosure requirement and no additional local financial disclosure is required.

This opinion is limited to the facts as you presented them to the Commission on Ethics and is limited to an interpretation of the County Ethics Code only and is not intended to interpret state laws. Questions regarding state ethics laws should be addressed to the Florida Commission on Ethics.

INQs are informal ethics opinions provided by the legal staff after being reviewed and approved by the Executive Director. INQs deal with opinions previously addressed in public session by the Ethics Commission or within the plain meaning of the County Ethics Code. RQOs are opinions provided by the Miami-Dade Commission on Ethics and Public Trust when the subject matter is of great public importance or where there is insufficient precedent. While these are informal opinions, covered parties that act contrary to the opinion may be referred to the Advocate for preliminary review or investigation and may be subject to a formal Complaint filed with the Commission on Ethics and Public Trust.
