Hi Sandy,

We spoke last week about a possible conflict of interest involving your service on the Miami-Dade Living Wage Commission and your occupation as an insurance broker. As I understand the facts, you sit on the Living Wage Commission, which enforces the Living Wage Ordinance, and a company seeking to do business with the County may be interested in purchasing insurance from you. There are two issues to address: 1) Whether you are transacting business with the County if this company becomes a County vendor and subsequently buys insurance from you and 2) Is a voting conflict created if this vendor has an item that comes becomes the Living Wage Commission?

Regarding #1, because you are not doing business directly with the County, no conflict of interest exists under the Code Section that covers transacting business with the County. Regarding #2, a conflict would be created if you in your capacity as of a member of the Living Wage Commission votes on any matters pertaining to this firm if the firm purchased insurance from you or the firm which employs you. If no such relationship is established, then no conflict would exist.
