Thank you for your request for opinion. I have had the opportunity to discuss this matter with the County Attorney and he concurs with opinion. Given the fact this question is being presented to me on an expedited basis, I have not shared it with the Miami-Dade Commission on Ethics for its consideration.

Based on the information you have provided me, I understand that County Commissioner Carlos Gimenez's son, Carlos J. Gimenez, is an associate at the law firm of Bilzin Sumberg Baena Price Axelrod LLP and two of the firm's partners were joined by Carlos J. Gimenez in presenting Application #6 to the Planning Advisory Board at its March 12, 2007 meeting. Your e-mail identifies Mr. Gimenez as a member of the firm's team, but it does not appear that he played a lead role concerning this application. Nonetheless, once Mr. Gimenez was mentioned as a team member to the Planning Advisory Board, a voting conflict would be created for County Commissioner Gimenez, preventing him from participating in or voting on Application #6. Therefore, despite the fact the applicant's property is located in District 7, Commissioner Gimenez should recuse himself when the application is presented at the March 28, 2007 meeting of the Board of County Commissioners. The conflict exists because the Commissioner's son was part of the team presenting this application. Had the law firm presented Application #6 without any involvement by Mr. Gimenez, a conflict of interest would not currently exist for County Commissioner Gimenez.
