Even assuming that Commissioner Diaz was involved in the decision as a co-chair of the Sports Commission to seek funding from the Tourist Development Council, no conflict of interest is created. As long as Commissioner Diaz does not benefit from the grant award to the Sports Commission, he can participate in the discussions and vote on the application as the chair of the Tourist Development Council. The only other prohibition worth mentioning is that Commissioner Diaz cannot present the application on behalf of the Sports Commission to the Tourist Development Council. If such a presentation is required, staff or another board member should handle it.
