Dear Mr. Vital,

I received your request for an opinion on June 4, 2007 and I inadvertently deleted your e-mail. I kept a hard copy of it and I also have a copy of the findings of my investigative staff regarding your position with the County and your interest in starting a home inspection business. You explained to my staff that your home inspection business will consist of inspecting electrical and plumbing systems and roofing prior to sale. Your clients will be homeowners and you do not plan on conducting this work for developers. As a Zoning Evaluator 2, you perform site plan reviews, inspect properties for zoning code violations, review the reports of inspectors and make recommendations.

Your work for the County does not appear to directly conflict with your home inspection business, but there are a few caveats I want to bring to your attention. You have to be extremely careful in terms of the marketing of your private business. It would be improper for you to mention your private business to those homeowners you come into contact with as Zoning Evaluator. Furthermore, you should refrain from discussing your private business with developers you deal with as a County employee as well. Finally, if your home inspection business requires you to interact with the County on behalf of a homeowner-client, you can only meet with County personnel regarding routine matters.

In conclusion, there is nothing in the county's Conflict of Interest and Code of Ethics Ordinance that absolutely prohibits you from starting your business, but you need to be mindful of the areas of concern that I have identified above. Please also understand that you must receive permission from your director before you commence your outside employment and you must report the income the business generates by filing the appropriate forms.

Mr. Vital came in for an interview about his projected outside employment and how it may conflict with his county duties as a Zoning Evaluator 2. Mr. Vital explained that his position as a Zoning Evaluator 2 includes the following duties:

- 1. Performs site plan reviews;
- 2. writes recommendations based on his meeting with the director of P&Z;
- 3. director makes recommendations and based on those recommendations he makes recommendations on the plan;
- 4. the Zoning inspector inspects the properties for zoning code violations, what is around the property, height of buildings around the subject property, uses around the property to make sure that it is compatible; and
- 5. makes recommendations based on inspector's report.

Mr. Vital plans on starting a home inspection business where he would inspect the electrical and plumbing systems as well as the roof and termites of a particular home prior to its sale. Mr. Vital stated that he would be dealing with homeowners and not developers.
