Hello Sheila,

To answer your question about the police filing outside employment income statements-

Every year, each police officer who has <u>worked for and been paid directly by</u> an outside employer should <u>list each outside employer by name and address</u> and, next to that information, the total amount of income derived over the course of the reporting year from each outside employer. If the officer worked for more than two outside employers, it will be necessary to use a separate sheet of paper to list each.

Inserting "varies" in place of the name and address of the outside employer is not a good solution. One of the goals of the form is to assure the public that no misuse of official position has occurred based on outside employment relationships.

The fact that the FOP coordinates these jobs is not relevant, but I've attached a Letter of Instruction we issued last year in the City of Miami Beach where a misunderstanding arose when the city coordinated off-duty outside employment for the police.
