Mr. Olmedillo,

Thank you for your email. As I understand it, you are part of a team of consultants that is likely to respond to a Miami-Dade County RFP and your daughter works for County Commissioner Rebeca Sosa as her Legislative Director. Assuming the RFP in question requires action/approval by the Board of County Commissioners, it would be a conflict of interest for your daughter to have any involvement whatsoever with this project. Often times, County Commissioners will have their staff brief them on agenda item or policy matter, but in this particular case it would be improper for your daughter to confer with Commissioner Sosa about this particular project. If she normally would handle these duties for the Commissioner, she must relinquish those responsibilities for this RFP. As long as she is separated from any discussions or decisions regarding this RFP, it would not be a conflict of interest for you to be a member of the team competing for the contract.
