As expressed below, given the possible interest of this firm, Delta Business Systems, to compete in the future Jackson RFP for MFD ("multifunction device" -- that is, copy/print/scan/fax office devices) equipment/services, I want to advise that I am a personal friend since 2000 of one of the owners of the firm, Mr. Cyrus Jiveh.

To avoid even the appearance of a conflict of interest, I want to recuse myself from any discussions with Delta Business Systems or its owners and officers concerning the future RFP. Instead, I shall instruct them, as I have below, to speak with other persons in the Jackson organization, and I will not speak with any representatives of the firm, including Mr. Jiveh, about the future RFP other than to refer them to the appropriate Jackson contact persons.

I will share this e-mail now with my two department directors, Tom Blaine and Rosa Costanzo, and also with Andrew Tuck (IT security/project "owner"), as well as the RFP manager in our Procurement Department, Rogelio Anasagasti. I am also copying our COO, Mr. Bassett, our CFO, Mr. Barrett, and our lead County Attorney here at Jackson, Mr. Shy, as well as Mr. Mike Nieto of Delta Business Systems.

If the firm should choose to compete and present a proposal under the future RFP, I will seek an advisory opinion from the County Ethics Commission for additional guidance.

William/Robert, please advise if you feel this is satisfactory at the present time, or if you have any questions, requests or suggestions whatsoever at this time.
