I apologize for not responding sooner to your question. I agree with the general proposition that the Council Member may use the Champions Room at the Speedway for a charitable event, but there has to be some benefit to the Homestead community. For example, if a Council Member were to hold a charitable event to benefit the March of Dimes of the Palm Beaches, there may not be a sufficient connection with the City of Homestead. On the other hand, if the charitable event were held for the benefit of the March of Dimes of Miami-Dade County, due to the fact the City of Homestead falls within the boundaries of Miami-Dade County, a sufficient nexus could be demonstrated.

In terms of measuring the impact, it wouldn't have to be calculated scientifically, but some generic benefit to area would be necessary.

Hi Robert- please advise as to whether you agree that under the Miami- Dade County Ethics Code a City Council Member may arrange with the operator of the Speedway for a charitable 501(c) (3) entity to use that Council Member's provisionally allocated City Day at the Champions Room at the Speedway for a charitable event , without requiring that the charitable organization demonstrate a measurable charitable program service delivery nexus within the City, so long as it is a bona fide charitable organization as described in Sec. 2-11.1 (e) (2) (g) and neither the Council Member nor his staff receives any compensation as a result of the event, as such compensation is likewise described in that subparagraph (g).
