Dear Mr. Silver:

The Miami-Dade County Conflict of Interest and Code of Ethics Ordinance requires that members of County boards are required to file financial disclosure forms. Exceptions exist in the County Code for citizen review committees and the Ethics Commission has found that Ad Hoc committee members are exempt from the financial disclosure requirement as well. The other consideration is that financial disclosure is only one of provisions of the county ethics ordinance. Therefore, a board member who is obligated under the law to complete the financial disclosure form must comply with all of the sections of the ethics ordinance --- one cannot be bound by certain provisions and exempt from others.

Given the composition of the charrettes, the purpose for which they are organized and their responsibilities, I am of the opinion that the members do not have to file financial disclosure forms.

Hi Robert,

Hopefully you can help shed light on this question. A little background information – when conducting a charrette, area plan or the like, steering committee members are generally appointed by commissioners or community council members. They are responsible for assisting staff in the preparation of planning documents for the specific area. The steering committee meets regularly with the staff and community residents. The number of meetings depends on the community's need and vary by project. In 2005, we were informed that steering committee members were bound to the Sunshine Law, however we never requested financial disclosure from committee members. Recently the question has been raised and we are in need of an opinion regarding the need for steering committee members to complete financial disclosure forms. It is our belief that they are serving in an advisory capacity that seems to fall under FS 112.3145(1)(a)(2)(e). Please advise.
