Limitations on Doing Business with the County

Dear Ms. Etchegaray:

In correspondence to our office on July 27, 2010, you said that you wish to do business with the County through your privately owned business, AIR TECHNIK, INC.

IT IS THE OPINION of the Ethics Commission staff that AIR TECHNIK, INC., may enter into contracts with the County, but not with the Miami-Dade County Clerk of the Courts Department because of your employment with the Clerk of the Courts.

THE FACTS as you presented them are that AIR TECHNIK, INC., a for-profit corporation owned by you, provides radio station electrical equipment. You are employed by the Clerk of the Courts as a Court Records Specialist 1.

THE COUNTY ETHICS CODE at Section 2-11.1 (c) allows your company to do business with Miami-Dade County as long as the contract does not interfere with the full and faithful discharge of your duties to the County. This includes the condition that you do not participate in determining the contract requirements or in awarding the contract. Additionally, none of your job responsibilities and job descriptions may require you to be involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination, or forbearance. Finally, you may not work in any County department that will enforce, oversee, or administer your contract.


