Limitations on Doing Business with the County

Dear Mr. & Mrs. Abreu:

In correspondence to our office on August 17, 2010, you said that you wish to do business with the County through your privately owned company, LAST MINUTE, INC., which provides natural and propane gas products and services.

IT IS THE OPINION of the Ethics Commission staff that LAST MINUTE, INC., may enter into contracts with the County, but not with the Miami-Dade County Fire Rescue Department because of the employment of Mr. Abreu's father with the Fire Rescue Department.

THE FACTS as you presented them are that LAST MINUTE, INC., is a for-profit corporation owned by you. Mr. Abreu's father, Carlos Abreu, Sr., is employed by the Miami-Dade Fire Rescue Department as a Fire Safety Specialist 2.

THE COUNTY CODE allows you to enter into a contract with Miami-Dade County as long as the contract does not interfere with the full and faithful discharge of Carlos Abreu, Sr.,'s duties to the County. This includes the condition that Carlos Abreu, Sr., not participate in determining the contract requirements or in awarding the contract. Additionally, none of Carlos Abreu, Sr.,'s job responsibilities and job descriptions may require him to be involved in the contract in any way including, but not limited to, its enforcement, oversight, administration, amendment, extension, termination, or forbearance. Finally, Carlos Abreu, Sr., may not work in any County department that will enforce, oversee, or administer your contract.


