#### Hello Carolina

If Mr. Maresma was required to comply with <u>State financial disclosure requirements</u> and filed a State Form 1F in April 2011, he does not have any other requirements under County law. This is because individuals who are required to file under State law automatically satisfy the County Code.

On the other hand, if a County employee is required to <u>file financial disclosure forms under the County Ordinance</u>, he should file a final disclosure form with the Elections Dept. within 60 days of his departure from County service. If that deadline has passed, he should file as soon as possible. In the case of an employee required to file under the County Code, any County-approved disclosure method is acceptable.

Please advise if this answers your question sufficiently.
