Mr. Del Rio,

This is in response to your question about post-employment restrictions following your retirement, on July 1, 2011, as a Transit Operations Supervisor with the Miami-Dade County Transit Department.

Specifically, you would like to work for a proposer on County Project No. 799 (Fixed Bus Route) as a Project Manager. You have stated that if the proposer, Transportation America, Inc., is successful, your role as a Project Manager will not involve lobbying in any capacity.

Under these facts, the Ethics Code does not prohibit Transportation America, Inc., from listing your name, along with a description of your experiences and qualifications, in its proposal. Additionally, you are not prohibited from being employed as a Project Manager by Transportation America, Inc., on this project.

Sec. 2-11.1 (q) of the County Code prohibits you from lobbying the County for two years following your County employment, but it does not prohibit you from being employed by a County contractor, as long as you do not lobby the County.

The Ethics Commission has issued numerous opinions on this prohibition. For example, in RQO 09-36, a former deputy director of the Aviation Dept. was allowed to manage a project in the North Terminal as an employee of a subcontractor because the former employee would not be lobbying.

Please be advised, however, that the definition of "lobbying" is very expansive. The Ethics Commission has consistently held that *any* attempt to influence an official government decision is likely to be considered lobbying. In your case, for example, you would not be allowed to meet or communicate with County officials or staff in an attempt to persuade them to make a decision on behalf of your employer. Additionally, County Commissioners and personnel have a duty to refuse to meet with you if they believe they are being lobbied. *See* Miami-Dade Co. Code at Sec. 2-11.1 (s)(10).

This opinion construes the Miami-Dade County Ethics Code at Sec. 2-11.1 only. It is not applicable to any conflicts under other sections of the County Code or to issues related to state or federal laws.

Re: Request For Advisory Opinion

Commission on Ethics:

I am a former County employee (recently retired) that has been offered a position as a Project Manager for a potential contract opportunity with Miami-Dade. It is important to note for purposes of this Request, that my role in this employment opportunity will be limited to that of a proposed Project Manager, and I will not be serving as a lobbyist in any capacity. I will simply be listed as the proposed Project Manager in the Proposal (including a description of my experience and qualifications), and may describe the tasks relative to my role in any presentations, if requested. If the proposer is awarded the contract, I will serve as the Project Manager.

I am aware of Section 2-11.1 (q) governing the "Two-Year Rule". In reviewing the "Library of Opinions" available on the Ethics Commission's Website, I have reviewed several opinions that basically states that the Ethics Code does not prevent former employees from serving as an employee of a company that might obtain a County contract or to serve as a subcontractor to a prime contractor for Miami-Dade. Specifically, in connection to Inquiry 11-21, in response to a similar inquiry from former County Commissioner Rolle, the Ethics Commission stated the following:

The rule does not extend to officials who work for companies doing business with Miami-Dade County and it also does not apply to an official who works for a firm doing subcontracting work for a prime contractor transacting business with Miami-Dade County. Thus, the Two Year Rule does not preclude you from taking a position with a firm doing work as a subcontractor at Miami International Airport. As previously stated, the rule simply prevents you from lobbying for the company and does not restrict other activities.

Although the above-referenced Opinion, as well as others posted on the Ethics Commission's Website, seem
clear to me, in an abundance of caution, I am hereby requesting an Advisory Opinion to confirm whether my
participation as a Proposed Project Manager for a proposer in a procurement opportunity does not create a
conflict with the aforementioned "Two-Year Rule".

Please be so kind to advise as soon as possible as time is of the essence in completing the proposal. Thank you for your attention in this matter.
