TO: Giulio Miglio, Highway Division, Public Works & Waste Management Dept.

Mr. Miglio,

You asked for an ethics opinion regarding engaging in outside employment as a construction qualifier. Secs. 2-11.1 (j) & (k) of the County Ethics Code as well as Administrative Order 7-1 apply.

You stated that you are a Highway Division employee whose primary duties involve reviewing plans. You would like to activate your Public Works Engineering Contractor License and work as a "qualifier" for a construction company that remodels private property.

As we discussed on the phone yesterday, we are hesitant to give a blanket endorsement of outside employment to qualifiers because a qualifier must be present on the private job site during regular business hours. Depending on the circumstances, a qualifier who leaves his County job to attend to private business could violate the Ethics Code.

A County employee's first duty is always to the County. According to Administrative Order 7-1, "County business must be conducted free of the influence of employees' personal and private financial interests, both in appearance and in fact." The County Ethics Code further states that a County employee may not accept outside employment that "would impair his or her independence of judgment in the performance of his or her public duties." *See* County Code at Sec. 2-11.1 (j).

I'm attaching two ethics opinions given to municipal employees who sought to work on private construction projects. In both cases, they were either required to hire a separate qualifier or assign another private employee as a qualifier, in addition to following numerous other safeguards, to insure that their responsibilities to their governments remained paramount. *See* RQO 08-29 and RQO 08-45.

Thank you for asking for our opinion on this matter. However, the ultimate decision to approve or disapprove of outside employment resides completely with your supervisor.
