Robert,

I believe that the Stonegate CDD is an independent special district—not subject to the County Ethics Code. CDDs are creatures of state statute.

Fla. Stat. 190.011 conveys many powers to CDDs that indicated independence from the county, e.g., CDDs can sue and be sued, acquire property, borrow money, issue bonds, and impose district ad valorem taxes.

CDD employees are allowed to participate in the state retirement system "in the same manner as if such employees were state employees." Chapter190 also provides for election of supervisors to the CDD board by the property owners in the district.

The resolution passed by the county doesn't limit the Stonegate CDD in any of these powers except to not allow it to apply for government grants without county approval.
